Usually, if your child requires this high level of support they will have been referred by the Local Authority. This is another way your child may be identified as not making as much progress as expected • If your child is then identified as not making progress the school will make a decision about whether to monitor this or set up an intervention group and will inform you • If your child is still not making expected progress the school will discuss with you <ul style="list-style-type: none"> ○ Any concerns you may have ○ Discuss with you any further interventions or referrals to outside professionals to support your child's learning ○ To discuss how we could work together, to support your child at home/school.

- the children getting extra support already
- the children needing extra support
- the children who have been identified as not making as much progress as would be expected.

A decision as to what resources/training and support is needed is then made.

This may include whole school training on SEND issues or to support identified groups of learners in school, such as ASC and Dyslexia Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g from the ASC service and Sensory service or medical /health training to support staff in implementing care plans Training takes place on a regular basis. This is something the government requires all schools to do and are the results that are published nationally • Pupils with specific SEN (in connection with reading or writing)or a statement, are given special consideration during the SATs . Pupils with specific SEN can be supported with reading and writing during certain tests and pupils with statements are given extra time to complete tests • Children at SEN Support will have an SEN Support plan which will be reviewed with your involvement, every term and the plan for the next term made • The progress of children with an EHC Plan/ Statement of SEN is formally reviewed at an Annual Review with all adults involved with the child's education • The SENCO and ASC Manager(for pupils within the provision) will also check that your child is making good progress within any individual work and in any group that they take part in • A range of ways will be used to keep you informed, which may include: <ul style="list-style-type: none"> ○ Termly parent's meetings ○ Letters/certificates sent home ○ Additional meetings as required ○ Reports
